Weekly Field Question: Can parents opt-out of testing their child? What about home-schooled children who are only present for select courses?



Opting-Out: Neither federal rules nor VT State Board policy recognizes a parent opt-out. The law requires schools to be held accountable for all their students. If you honor a parent's request for an opt-out, we are required to enter a score of zero for that student in reporting and accountability. Home-Schooled Students: Although you are not required to assess students who are home schooled, as a courtesy, parents of home schooled children can make arrangements to have their students tested by their designated public school, but it needs to be at your convenience and when similar students are being tested in your schools (e.g., if the student would be a 4th grader if s/he attended public school, then the student should come in and be tested when you're testing your 4th graders).
