From the Test Director: A Little Light Housekeeping

We've got a few chores we need to do over the next several weeks that are the first of many we need to complete to be ready for testing in mid-March. First and foremost, we need to make sure we have a District Test Administrator (DA) for every Supervisory Union/Supervisory District. Then the DAs will initiate the process of designating and assigning passwords to individuals who will serve in other test administration roles: District Coordinators (DCs), School Coordinators (SCs), Teachers who will administer the tests (TEs), and other individuals who will administer the test (TAs). Here's how the process will work:

- ✓ Superintendents will receive an e-mail from us with a list of the current DAs attached. They will be asked to (a) confirm that the current DA will continue in that role, or (b) name a new DA.
- ✓ Once we hear from your superintendent we will clean out all the inactive DAs and enter their replacements.
- ✓ In the meantime, on or near the 27th, all of last year's users will receive an e-mail from our testing contractor, American Institutes for Research (AIR), that will provide directions for resetting passwords. Everyone MUST change passwords each year because it is one of our methods for maintaining test security. This e-mail will also include a temporary password that can be used to access the secure side of the assessment portal and set a new permanent password for this year.
- ✓ When TIDE opens on October 6th, DA's should remove any inactive users and add their replacements. After the school coordinators are identified and entered into TIDE, they can add new TEs and TAs and clean out any individuals who will no longer be involved in test administration.

Answer: We do report data for both Free Reduced Lunch (FRL) and Not Free Reduced Lunch (NFRL) in the Online Reporting System and in the [spreadsheets](#) that are available on the AOE website. However, the interactive report viewer on the AOE website does not include FRL/NFRL.
