“When entering new students into the TIDE system for 2015 testing, the student ID field (aka SSID, state assigned ID, perm-number) will be required. Many registrars and guidance personnel in your schools enter this ID into your school’s student information system (SIS) and, therefore, they may be a good source for the ID. If you need to request IDs from the State for a small number of students, the easiest way is to complete and fax the Student ID number request form below. http://education.vermont.gov/documents/EDU-Data_Collection_Student_ID_Number_Request.pdf. If you have a large number of new students needing to be entered into the TIDE system, please contact Jennifer Perry 802-479-1056 to discuss secure file transfer options.” **Glenn Bailey, Education Analysis & Data Management Director**
